1. Welcome and Introductions
  - a. For everyone to get acquainted, participants in-person and online introduced themselves and stated their affiliation.
2. Approval of the June 30<sup>th</sup>, 2021 Meeting Minutes
  - a. Beth Fugate (DEP) made a motion to approve the minutes. Anne Birch (TNC) seconded the motion. The motion passed unanimously.
3. Restoration Project Implementation overview (*See presentation PDF*)
  - a. A. Birch presented a pilot oyster restoration project draft concept that she has been working on as part of a larger planning effort with The Nature Conservancy. In addition to working on an oyster management plan for the state of Florida, Anne has been working with colleagues to develop a draft concept of a multi-site, multi-objective restoration project for oysters in the Pensacola Bay System (PBS). This project would assist in implementing the Priority 1 strategies identified in the Oyster Fisheries and Habitat Management Plan.
  - b. D. McMahon expressed interest in assisting to secure potential funding sources for this large-scale project and developing future collaborations. There was also discussion surrounding the incorporation of the Habitat Suitability Model outputs and oyster mapping efforts into project planning and the new permitting authorization from the Florida Department of Agriculture and Consumer Services (FDACS).
4. East Bay Oyster Restoration Project Update
  - a. A. Birch gave a brief overview of the status of the NFWF/GEBF funded restoration project that is being conducted in East Bay. The project has experienced setbacks due to storms and the pandemic, but 1 reef unit has been fully constructed with 2 more close to completion. She also mentioned that D. Boudreau (NFWFMD) will be collecting drone footage during the reef construction process on a regular basis.
  - b. A. Birch offered to give a more in-depth presentation on the project with videos and photos at a future meeting.

5. Oyster Sub-Committee Leadership Vote
  - a. W. Scheffel announced that the two candidates that volunteered to serve as co-chairs at the last sub-committee meeting were Beth Fugate (DEP) and Chris Verlinde (UF/IFAS).
  - b. W. Scheffel asked if any other members were interested in serving as chair or co-chair or if a member would like to nominate someone for the role. There were no additional volunteers or nominations.
  - c. A. Birch made a motion to select B. Fugate and C. Verlinde as co-chairs of the sub-committee. D. McMahon and P. Sapp seconded the motion. The motion passed unanimously.

6. National Estuaries Week
  - a. Logan McDonald (PPBEP) presented a calendar of upcoming events in celebration of “National Estuaries Week” (Sep. 18-26). Some of the activities include a Lunch & Learn virtual tour of the East Bay Oyster Restoration Project led by TNC, Community Grant Symposium at the Studer Community Institute, and an Oyster Boat Tour on the Pensacola Bay ferry.

  - a. Discussion continued regarding the importance of identifying potential funding for oyster projects/programs and potential partners that are interested in getting involved.
  - b. Future meetings will highlight the priorities of the sub-committee including revisiting the priority 1 strategies from each of the themes in the Oyster Management Plan.

  - a. B. Smith (Grayson Bay) asked if there were any plans to divide the PBS into smaller sub-sections or grid system for referencing specific projects on a smaller scale or targeting future project locations. S. Alexander (SRC) commented that there will be a Living Shoreline Suitability Model output from a NFWF funded project that would provide additional information regarding target areas for improvements in the PBS.
