1. Presentation, Whitney Scheffel

- a. Anne Birch, TNC, announced that the East Bay Oyster Habitat Restoration project is scheduled to break ground on July 14 (*since rescheduled to August*). The project will construct 33 oyster reefs along Blackwater and East Bays in Santa Rosa County.
- b. Whitney Scheffel, PPBEP, provided a recap for participants about PPBEP's role of incorporating the Oyster Fisheries and Habitat Management Plan priorities into the Program's CCMP and information/updates on oyster related efforts.
 - 1. PPBEP have completed drafts of their Education and Outreach Strategic Plan and Action Plan
 - a. EOC members provided feedback on the draft Education and Outreach strategy on June 24th.
 - b. TC members will review and provide feedback on the PPBEP draft Action Plan on July 27th.
 - 2. PPBEP oyster related efforts:
 - a. Education and outreach initiatives
 - b. National Estuaries Week events
 - c. Research related efforts
 - d. Living Shoreline Marine Contractor Training (Community Grant funded)
 - e. Monitoring
 - i. National Coastal Condition Assessment and National Wetland Condition Assessment intensifications (NCCA/NWCA)
 - 3. Oyster mapping update
 - a. Escambia and Santa Rosa Counties
 - i. MREC working with PPBEP and TNC staff to conduct oyster mapping and analysis in the Pensacola Bay system.
 - ii. Final reports for both counties will be completed by the end of August 2021.
- 2. Oyster Sub-Committee Structure Discussion
 - a. Sub-Committee overview (See Pg. 2)
 - i. W. Scheffel presented the oyster sub-committee overview and requested feedback on the structure, membership, and tasks of the committee. The sub-committee will be composed of standing members of the oyster stakeholder working group and other interested parties.
 - b. Fact-finding vs. Advisory (See Pg. 3)

- i. Participants reached consensus on the oyster sub-committee remaining a fact-finding sub-committee of the PPBEP's Technical Committee and will provide feedback to PPBEP staff for recommendations to the Policy Board (when applicable).
- c. Chair and Co-Chair responsibilities (See Pg. 3)
 - i. Discussion on roles of the committee chair and co-chair. Chris Verlinde, UF/IFAS, and Beth Fugate, DEP, volunteered to serve as co-chairs.
- 3. General Discussion
 - a. Katie Konchar, FWC, asked if the fish community surveys conducted by Dr. Baker, DISL/USA, overlapped with areas scanned in the oyster mapping effort. W. Scheffel confirmed that the areas surveyed overlapped with sites mapped by MREC.
 - b. Meeting participants discussed general intent of the oyster subcommittee and agreed to focus on prioritization and future goals during the next meeting.
 - c. Kent Smith, FWC, suggested that oysters may be a good focus area/flagship for the PPBEP, like Tampa Bay Estuary Program (TBEP) and their focus on seagrass.
- 4. Next Meeting (*tentative* August 24th)
 - a. At the next meeting, the committee will vote on and appoint chair and/or co-chairs.
 - b. Anne Birch and Katie Konchar offered to present on a proposed restoration project that is based on outputs from the existing Habitat Suitability Model (TNC) and the Ecosystem Services Model (EPA/TNC).
 - c. Logan McDonald, PPBEP, mentioned the need for committee input on a future oyster documentary film the Program hopes to move forward on in the near future.
 - d. Meeting participants will discuss future meeting content and committee goals and project prioritization. The format of the next meeting will be a hybrid (in-person/virtual) format.
 - e. Anne Birch and Kent Smith suggested that prioritizing committee actions should be a critical component of upcoming meetings.
 - f. Anne Birch suggested that the committee alternate meeting times between daytime and evenings in order to ensure that watermen are able to attend.
